**If you are a member of a Medicare Advantage Plan** (like an HMO or PPO), you may already have a prescription drug benefit from your Medicare Advantage plan that will meet your needs. By joining Asuris Medicare Script, your membership in your Medicare Advantage plan may end. This will affect both your doctor and hospital coverage as well as your prescription drug benefits. Read the information that your Medicare Advantage plan sends you and if you have questions, contact your Medicare Advantage plan.

**If you currently have health coverage from an employer or union, joining Asuris Medicare Script could affect your employer or union health benefits.**

If you have health coverage from an employer or union, joining Asuris Medicare Script may change how your current coverage works. Read the communications your employer or union sends you. If you have questions, visit their Web site, or contact the office listed in their communications. If there is no information on whom to contact, your benefits administrator or the office that answers questions about your coverage can help.

**Typically, you may enroll in a Medicare prescription drug plan only during the annual enrollment period between November 15 and December 31 of each year.** Additionally, there are exceptions that may allow you to enroll in a Medicare prescription drug plan outside of the annual enrollment period.

### By completing this enrollment application, I agree to the following:

Asuris Medicare Script is a Medicare drug plan and has a contract with the Federal government. I understand that this prescription drug coverage is in addition to my coverage under Medicare; therefore, I will need to keep my Medicare coverage. It is my responsibility to inform Asuris Medicare Script of any prescription drug coverage that I have or may get in the future. I can only be in one Medicare prescription drug plan at a time - if I am currently in a Medicare prescription drug plan, my enrollment in Asuris Medicare Script will end that enrollment. Enrollment in this plan is generally for the entire year. Once I enroll, I may leave this plan or make changes if an enrollment period is available, generally during the Annual Enrollment Period (November 15 - December 31), unless I qualify for certain special circumstances.

Asuris Medicare Script serves a specific service area. If I move out of the area that Asuris Medicare Script serves, I need to notify the plan so I can disenroll and find a new plan in my new area. I understand that I must use network pharmacies to access Asuris Medicare Script benefits, except under limited, non-routine circumstances when I cannot reasonably use Asuris Medicare Script network pharmacies. Once I am a member of Asuris Medicare Script, I have the right to appeal plan decisions about payment or services if I disagree. I will read the Evidence of Coverage document from Asuris Medicare Script when I receive it to know which rules I must follow in order to receive coverage with this Medicare drug plan.

**I understand that if I leave this plan and do not have or obtain other Medicare prescription drug coverage or creditable coverage (as good as Medicare's), I may have to pay a late enrollment penalty in addition to my premium for Medicare prescription drug coverage in the future.**

I understand that if I am receiving assistance from a sales agent, broker, or other individual employed by or contracted with Asuris Medicare Script, he/she may be compensated based on my enrollment in Asuris Medicare Script. This compensation does not affect my premium in any way.

Counseling services may be available in my state to provide advice concerning Medicare supplement insurance or other Medicare Advantage or Prescription Drug plan options and concerning medical assistance through the state Medicaid program and the Medicare Savings Program.

**Release of Information:** By joining this Medicare prescription drug plan, I acknowledge that Asuris Medicare Script will release my information to Medicare and other plans as is necessary for treatment, payment and health care operations. I also acknowledge that Asuris Medicare Script will release my information including my prescription drug event data to Medicare, who may release it for research and other purposes which follow all applicable Federal statutes and regulations. The information on this enrollment form is correct to the best of my knowledge. I understand that if I intentionally provide false information on this form, I will be disenrolled from the plan.

I understand that my signature (or the signature of the person authorized to act on behalf of the individual under the laws of the State where the individual resides) on this application means that I have read and understand the contents of this application. If signed by an authorized individual (as described above), this signature certifies that 1) this person is authorized under State law to complete this enrollment and 2) documentation of this authority is available upon request by Asuris Medicare Script or by Medicare.
